End-user License Agreement

- 2) Two ways to retrieve your hotsync name:
 - a. On the reminder view, tap the [Register] button and the register view will be displayed. On the upper center of the register view is your displayed hotsync name.
 - b. Or the main view, tap the menu to bring it down, then tap Info then Registration, this will bring up the register view. On the upper center of the register view is your displayed hotsync name.

CHAPTER II: INSTALLATION INSTRUCTIONS

- 1) Download the application at <http://www.palmgear.com>
- 2) If you have downloaded a zip file (.ZIP file for Windows or .SIT file for Mac), extract its contents to a folder. Take note of the folder location, you will need to access the files to install them to your Palm device.

Tip: You will need a zip file extraction software to extract the files. You can obtain any of the popular zip extraction software. For Windows, you can use WinZip from www.winzip.com. For Mac, you can use StuffIT from www.aladdinsys.com.

- 3) Double-click on the following files **ChessQuantum.prc** to install them to your Palm device.

The **Palm Install Tool** will flag the files for installation during the next operation.

HotSync Optional Step: To change the destination within the Palm Install Tool.

To change the destination, If ever you want to install the application in an expansion card, you need click on the "Change Destination" button located directly below the list of files. In the "Change Destination" screen, select the expansion card. After you have selected them, click on "OK".

Tip: An expansion card is a memory storage device that allows you to store files. An expansion card comes in different sizes, from 32MB to 128MB. There are three common types of expansion card: Secure Digital Card (SD Card), Compact Flash Card (CF Card), and Memory Stick (MS). Depending on your device, you may have one of the three types, please refer to your device's manual for more information on the supported expansion card type.

- 4) Perform the HotSync operation for your device. This step transfers all files to your Palm device or to your selected expansion card. Please be patient with the operation, it may take a while to complete the transfer due to its size.

CHAPTER V: FAQ

- I have a second PDA. Can I use the same license key for this second PDA?

Answer: The Chess Quantum license key is unique to every device. You have to purchase another one for your second handheld.

- I just purchased and downloaded your product and it is asking me to register the product as if it was a trial version.

Answer: Newly registered users of the Chess Quantum will be sent license keys/registration code to unlock the trial version. Please allow us up to two working days to process your license key/registration code.

- Does the Chess Quantum supports memory sticks?

Answer: YES.

- Does Chess Quantum support Mac?

Answer: YES.

- What is the minimum requirements for this product to be able to run on a device?

Answer: a minimum of Palm OS 3.5 and above. With a 916KB of memory storage and 64KB of dynamic memory.

- My registration code doesn't work what gives?

Answer: The registration code or license key is based on the on your HotSync name. Please send us the correct HotSync name for us to revise your license key.

Note: This application will not accept a device with no PALMID/HotSync Name.

- I recently purchased the Chess Quantum but I haven't gotten my registration code/License key yet.

Answer: Please allow us up to 2 working days to process your registration

- Can I use the same license key for my wife or friend's PDA?

Answer: No. The license key you purchased can only be used on a single PDA.

- How do I unzip the file?

Answer: The file you downloaded from the Internet comes in a Zip Format. You need to extract it first before you could install it to your PDA.

You will need an extraction tool to do this.

- How long does it take for me to download the files?

Answer: If you're using a dial-up connection, try downloading during off-peak hours.

- When I tried to install memory? it says I have no enough memory. Where do I get more?

Answer: cards gives you an extra 140mb on your memory while others offer as much as 4 MB. Most of later generation PDA's supports expansion cards. Standard GB of added memory. If your PDA does not support memory cards, please remove other software and files to accommodate the Chess Quantum.

- How do I know the HotSync will install the file in the next synchronization?

Answer: To confirm that HotSync will install the files in the next synchronization, launch the palm Install tool. To run, go to your Start menu, click on your device's program folder, then click "Install tool". In the program screen, you should see Chess Quantum on the list.

- Do I need a separate license key / registration code for this product?

Answer: Yes, you have to purchase a separate license key for it.
